Sealed quotations are invited for Supply, Installation, Testing and Commissioning of Solar street lighting system in IDRBT premises, and should be addressed to the Director, IDRBT, Masab tank, Hyderabad, so as to reach IDRBT not later than 14.00 hrs on 10.07.2013.

- 1. The Institute reserves the right to accept or reject any or all the quotations in full or in part without assigning any reasons thereof and also reserves the right to accept the quotation of any firm partly or fully.
- 2. The quotation shall be valid for a period of 30 days from the date of opening of the same.
- 3. The firm is requested to quote unit rates and amounts separately in the enclosed Performa (Bill of Quantity) only.
- 4. The firm shall furnish Earnest Money Deposit in the form of a Demand Draft in favor of IDRBT, Hyderabad for a sum of Rs.9,000/-. The EMD does not carry any interest and the same will be released after completion of Defects Liability Period (DLP) of one year from the date of completion of work to the successful bidder or on submission of Bank Guarantee for said amount and said period. Quotation, which is not accompanied by EMD in the form of DD, will not be considered. However, EMD will be returned to the unsuccessful bidder after placing the work order with successful bidder.
- 5. The rates quoted shall be inclusive of all taxes, duties, levies, transport, packing, forwarding charges, and including installation charges etc.
- 6. TDS will be deducted from the payments made to the firm.
- 7. The payments for solar street light system will be made by IDRBT, Hyderabad to which the solar street light work is to be done in IDRBT building, Hyderabad. The dispute arising out of the contract will also be sorted out within the jurisdiction of Hyderabad, A.P.
- 8. The firm may consult Institute's Engineer (Cell: 9440803812) and should thoroughly acquaint themselves with the nature with the scope of work before quoting.
- 9. The entire Supply and Installation, Testing and Commissioning of Solar street lighting system shall be completed within Two months from the date of work order, failing which Liquidated Damages (LD) at the rate of 0.25% of the tender cost per week for the delay in completion of work beyond the stipulated period with an upper ceiling of 5% of the contract amount will be levied.

- 10. The following terms of payment will apply to the contract.
 - a) 95% of the quoted rate will be released after completion work an actual measurement basis.
 - b) Balance 5% of the quoted rate will be released after expiry of defects liability period of one year OR on submission of Bank Guarantee for said amount for said period.
- 11. The firm shall make good the damages caused to the Institute's property during the execution of the materials at no extra cost.
- 12. The firm shall be fully responsible for all type of loss, damages during the execution of the materials including Mishap/accident to any person.
- 13. The firm should quote on the above terms and conditions as per the enclosed bill of quantities and no deviations are being allowed. The quotation will not be considered if any deviation found in the above terms and conditions.
- 14. The EMD will be forfeited, if the firm fails to execute the work after placing the work order.
- 15. The materials proposed to be use shall be date approved by Institute's Engineer before installation.

 The work is to be carried out in consultation with Institute's Engineer.
- 16. The Solar Street Lights should under warrantee 2 years for system and 10 years for solar module.
