### 1. Introduction

## 5. Bidding Process

A two stage bidding procedure will be followed. The response to the present tender will be submitted in two parts i.e. the Technical Bid and the Commercial Bid.

In the first stage, only the 'Technical Bids' will be opened and evaluated. Those bidders satisfying the technical requirements of **Supply of Redhat Enterprise Linux 7.4.x Software – Support and Subscription Services for IDRBT**, as determined by the IDRBT and as per the requirements/specifications in Annexure – I and the terms and conditions of this document, shall be short-listed. In Second Stage, Commercial bids of technically qualified vendors will be opened

## 6. The Commercial Bid should contain the following:

The bidders are required to submit a copy of the Technical Bid highlighting the features to be supplied along with the Commercial Bid. The format of Commercial Bids to be submitted is given in Annexure – III.

Taxes if any should be explicitly stated in the Commercial Bid along with the delivery schedule. Bids sealed in accordance may be sent by registered post or hand delivered so to be received at the above-mentioned address:

## 7. Terms & Conditions:

1. All bids and supporting documentation shall be submitted in English.
2. IDRBT will not take into consideration, any variation in the \$ price.
3. All costs and charges, related to the bid, shall be expressed in Indian Rupees only.
4. Entry/Octroi will be paid at actuals on production of invoices for the same and should not be included in the total amount.
5. The Supply of Support and Subscription should be done within 01 (One) week from the date of purchase order.
6. The Bidder is liable to be rejected if any commercial details are found along with the technical bid.
7. The cost of bidding and submission of the bids is entirely the responsibility of the Bidders, regardless of the conduct or outcome of the tendering process.
8. The bidder should be an Original Equipment Manufacturer or an authorized supplier/representative of OEM in India. An Authorization letter from the manufacturer to this effect should be furnished as enclosed in Annexure II.
9. IDRBT reserves the right to reject all or any of the quotations without assigning any reason thereof.
10. The decision of IDRBT shall be final.
