### Introduction

Domain Names and Digital Certificates are essential digital identities for any organisation functioning in digital way. At present, the banks domain names are scattered across different Top Level Domains, i.e., .com, .co.in, .org.in, etc., confusing the banks customers in identifying the original identity. Many of times, this leads to common people falling prey to cybercrimes.

The Reserve Bank of India has announced the introduction of '.bank.in', an exclusive internet domain to combat the increased instances of fraud in digital payments. This initiative is aimed at strengthening the cybersecurity framework. Registering a domain under .bank.in will enable customers to easily identify the genuine identity of the bank and reduce the cybercrimes.

IDRBT is the exclusive Domain Registrar of .bank.in. The RBI, vide its Circular dated April 22, 2025, has decided to operationalise the .bank.in domain and the banks need to migrate to the .bank.in domain at the earliest. Banks need to apply to IDRBT to get a domain name registered. Post obtaining a domain name, banks have to migrate to the new domain name.
