Tenders with incomplete or broken seals are liable to be rejected, the matter solely resting at the discretion of the Employer. If a contractor does not quote for one or more items, the Tender will be considered as incomplete and will be rejected.
3. Clients reserve to itself the right to accept or reject any tender without assigning any reason for doing so and does not bind itself to accept the lowest or any other tender.
4. Employer or Client shall mean Institute of Development and Research in Banking Technology (IDRBT), Castle Hills, Road No-1, MasabTank, Hyderabad-500057.

DETAILS OF THE TENDER

1 INSTRUCTIONS TO BIDDER

1.1 General Terms and Conditions

- 1) All efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 2) The bidder shall attach the copy of the authorization letter / power of Attorney as proof of authorization for signing on behalf of the Bidder.
- 3) All Bidders are hereby informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids, not accompanied with EMD of requisite amount/format, or any other requirements, stipulated in the tender documents are liable to be rejected.
- 4) For all purposes of the contract including arbitration thereunder, the address of the bidder mentioned in the bid shall be final unless the bidder notifies a change of address by a separate letter sent by registered post with acknowledgement due to the Office of the IDRBT, Hyderabad. The bidder shall be solely responsible for the consequences of any omission or error to notify change of address in the aforesaid manner.
- 5) The requirements of procurement of furniture as mentioned in the tender document is tentative and may increase or decrease at the sole discretion of the competent authority of the Client.

1.2 EARNEST MONEY DEPOSIT

- 1) Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid EMD shall be forfeited to the IDRBT.
- 2) The bids without Earnest Money Deposit shall be summarily rejected. No claim shall lie against the IDRBT in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit.
- 3) The bid security (earnest money deposit) may be forfeited:
 - i. If the bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form; or
 - ii. In case of successful bidder, if the bidder:
 - a) Fails to sign the contract in accordance with the terms of the tender document.
 - a) Fails to furnish required security deposit in accordance with the terms of tender document within the time frame specified by the Client.

- b) Fails or refuses to honor his own quoted prices for the services or part thereof.
- c) In such case, the bidder is also liable to be debarred from future tendering.
- 4) No interest shall be paid on the earnest money deposit.

1.3 FINANCIAL BID

- 1) The Bidder shall be required to quote their prices in a single consolidated statement "Bill of Quantity (BOQ)" template which is available in the tender document.
- 2) The Bidder should quote rates for each and every item in terms of per piece and only in Indian Rupees (in figures as well as words in English). In case of difference of rate in figures and words, rate written in words shall only be considered.
- 3) If rate is not quoted for all the items, the bid will not be valid and hence the same will be rejected. The consolidated price of all the items will be taken into consideration while awarding of contract to the successful bidder.
- 4) The rates quoted shall be firm and final. The price should be inclusive of all i.e., cost of article, inspection of item, transportation, delivery, shifting of items from ground floor to third floor, installation etc. and all other applicable taxes and duties except GST, if any.
- 5) At the time of payment of bills, the income tax and any other tax / duty etc. that is required to be deducted, shall be deducted at source as per Government rules and guidelines as may be prevailing at the time of payment.
- 6) evaluation shall be done only in respect of Valid Bid.

1.4 DETERMINATION OF THE SUCCESSFUL BIDDER

- 1) The technically qualified Bidder meeting the minimum eligibility criteria with the lowest bid price, subject to arithmetical correction, shall be deemed as the successful Bidder. The consolidated price of all the items will be taken into consideration for determination of the successful bidder.
- 2) In the event of more than one bidder with the lowest price bids (say equal), the bidder with the highest 'cumulative annual turnover of the last 3 financial years would be deemed as 'Successful Bidder' with respect to the submission of proof of documents as submitted by the bidder.

1.5 RIGHT OF ACCEPTANCE

- 1) IDRBT reserves all rights to reject any bids including of those bidders who fail to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific bids. The decision of the Competent Authority of the IDRBT in this regard shall be final and binding.
- 2) Any failure on the part of the bidder to observe the prescribed procedure and any attempt

to canvass for the work shall render the bidder's bids liable for rejection.

- 3) The competent authority of the Office of the IDRBT reserves the right to award any or part or full contract to any successful agency (ies) at its discretion and this shall be binding on the bidders.
- 4) In case of failure to comply with the provisions of the terms and conditions mentioned, by the agency that has been awarded the contract, the competent authority of the IDRBT reserves the right to award the contract to the next lowest bidder or any other outside agency.
- 5) The IDRBT shall terminate the Contract if it is found that the Contractor was blacklisted on previous occasions by any of the Government Departments / Institutions / Local Bodies / Municipalities / Public Sector Undertaking etc. In such case, the Contractor is also liable to be blacklisted by the Client.

1.6 RETURNING OF EARNEST MONEY DEPOSIT (BID SECURITY AMOUNT)

- 1) The Earnest Money Deposit of the unsuccessful bidders in the technical Bid evaluation stage shall be returned within 7 (seven) days after opening of the eligible financial Bids.
- 2) The Earnest Money Deposit of the unsuccessful bidders in the financial bid evaluation stage shall be returned within 7 (seven) days, on award of contract to the Successful bidder.
- 3) The Earnest money deposit of all the bidders shall be returned in case of cancellation of Tender after the opening of Bids and prior to opening of financial bids.
- 4) No interest shall be paid on Earnest Money Deposit.

2. GENERAL CONDITIONS OF CONTRACT (GCC)

2.1 DEFINITIONS

In this Contract including the Schedules the following words and expressions shall (unless the context requires otherwise) have the meaning assigned to them in this Schedule.

Agreement	The word “Agreement” and “Contract” has been used interchangeably.
Party	The word party means the Successful Bidder and the Client “IDRBT, Hyderabad “
Letter of Acceptance	Shall mean the intent of the Client to engage the successful bidder.
Termination Date	Shall mean the date specified in the notice of Termination given by either Party to the other Party, from which the Contract shall stand terminated.
Termination Notice	Shall mean the notice of Termination given by either Party to the other Party.
Contractor	Shall mean the successful bidder to whom the work order has been awarded.

2.2 CONFIDENTIALITY

The Contractor shall take all precautions not to disclose, divulge and / or disseminate to any third party any confidential information, proprietary information on the Client’s business or security arrangements and/or business of the Client. The obligation is not limited to any scope and the Contractor shall be held responsible in case of breach of the confidentiality of Client’s information.

a. NOTIFICATION OF AWARD BY ISSUANCE OF ‘LETTER OF ACCEPTANCE’

After determining the successful bidder, Client shall issue a Letter of Acceptance (LoA) in duplicate, who will return one copy to Client duly acknowledged, accepted and signed by the authorized signatory, within Three (3) days of receipt of the same by him. The issuance of the Letter of Acceptance to the bidder shall constitute an integral part and it will be binding to the contract.

a. SIGNING OF CONTRACT AGREEMENT

- i. The successful Bidder shall enter into contract and shall execute and sign the Contract Agreement in accordance with the Articles of Agreement.

b. WARRANTY OF QUALITY AND QUANTITY

- i. All the modular furniture supplied by the Contractor in Client's premises shall carry a mandatory minimum warranty of one year from the date of installation and commissioning.
- ii. The Contractor, by way of signing the tender document, gives an undertaking that their products carry warranty of one year on modular furniture items which are in conformity with the specifications and are conforming to the specified design and there are no defects in the process of manufacturing & installation.

- iii. In case of any defect found within one year from the date of supply, items should be repaired free of cost and if repair is not possible the same should be replaced with a new one.
- iv. Upon receipt of notice from department for defective material, the Contractor shall within 7 days of receipt of the notice, replace the defective material, free of cost at the destination. The Contractor shall take over the defective material at the time of replacement. No claim whatsoever shall lie on the Client for the replaced goods thereafter. If the Contractor fails to replace the defective goods within the period, the department may proceed to take such remedial actions as may be necessary, at the Contractor's risk and expense besides forfeiting the Security Deposit and taking action to blacklisting the Contractor.

c. CONTRACTOR'S LIABILITY

- i. The Contractor shall completely indemnify and hold harmless the Client and its employees against any liability, claims, losses or damages sustained by it or them by reason of any breach of contract, wrongful act or negligence by the Contractor.
- ii. The Contractor shall not be liable in any way whatsoever and the Client hereby expressly waives any right to, any loss, injury, damage, cost or expense of whatsoever nature directly or indirectly (i) caused by, resulting from or in connection with any Biological or Chemical Contamination or any Nuclear Risks; (ii) consisting of, caused by, resulting from or in connection with any loss, damage, destruction, distortion, erasure, corruption or alteration of Electronic Data from any cause whatsoever (including but not limited to Computer Virus) unless such loss, damage, destruction, distortion, erasure, corruption or alteration of Electronic Data was due to the negligence or default of the Contractor or any of its employees engaged in the provision of the Contract to the Client.
- iii. The Contractor shall not Sub-Contract, transfer or assign the contract or any other part thereof without prior written permission of the Client. In the event of the contractor contravening this condition, Client shall be entitled to place the contract elsewhere on the contractor's risk and cost and the contractor shall be liable for any loss or damage, which the Client may sustain in consequence or arising out of such replacing of the contract.

d. LIQUIDATED DAMAGES

The date of delivery and quality of modular furniture items stipulated in the acceptance of tenders should be deemed to be essence of the contract and delivery must be completed not later than three weeks from the date of award of work/supply order. In the event of delayed delivery after expiry of the contracted delivery period, the Client shall levy a penalty @ 5% per week, on the total value of the late delivered quantity for the period by which it exceeds the stipulated time period, from the date of issue of the formal work/supply order, subject to a

maximum of 15 %. In the event of delay of more than two weeks, the Client will have the right of revoking purchase order and forfeiting the Security Deposit.

e. GOVERNING LAWS AND SETTLEMENT OF DISPUTE

- i. Any claims, disputes and or differences (including a dispute regarding the existence, validity or termination of this Contract) arising out of, or relating to this contract including interpretation of its terms shall be resolved through joint discussion of the Authorized Representatives of the concerned parties. However, if the disputes are not resolved by the discussions as aforesaid within a period 30 days, then the matter will be referred for adjudication to the arbitration of a sole arbitrator to be appointed by the parties in accordance with the provisions of the Arbitration and Conciliation Act 1996 and rules made thereunder including any modifications, amendments and future enactments thereto. The venue for the Arbitration will be Hyderabad and the decision of the arbitrator shall be final and binding on the parties.
- ii. Jurisdiction of Court: This Contract is governed by the laws of Republic of India and shall be subject to the exclusive jurisdiction of the courts in Hyderabad.

f. TERMINATION

This Contract may be terminated by the Client in case the Contractor is found in material breach of its obligations under this Contract Agreement. In the event of breach of the terms and conditions of the contract, the contract shall be terminated, and nothing shall be payable by the Client. The Client shall also blacklist the Contractor and forfeit the security deposit for its breach of terms and conditions of the Contract.
